Mobile Crisis Intervention (MCI)	Short-term service that is a mobile, on-site, face-to-face therapeutic response to youth experiencing a behavioral health crisis for the purpose of identifying, assessing, treating and stabilizing the situation and reducing immediate risk of danger. Provided 24 hours a day, 7 days a week. *Clinicians are able to support families in crisis for up to 7 days after the initial evaluation is completed. Intensive Residential Treatment Program (IRTP-Adolescents) Children's Intensive Residential Treatment (CIRT-Latency Age Children) *CIRT not available in Eastern MA.	Time-limited mental health services provided in a secure residential setting. Recipients of IRTP are in need of structure and assistance from 24-hour mental health staff and at risk of significant functional deterioration if they do not receive these services. They are designed to develop and enhance psychiatric stability, personal and emotional adjustment, self-sufficiency and skills to live more independently.	DMH Special Education in Institutional Settings (SEIS)	Acute inpatient referral only

Community-Based Acute Treatment (CBAT)	Treatment provided to youth with serious behavioral health disorders who require a 24-hour-a-day, seven-day-a-week, staff- secure treatment setting. It provides crisis stabilization, therapeutic intervention and specialized programming with a high degree of supervision and structure.	MassHealth and various private health insurance providers	Must be screened through MCI
Intensive Community-Based Acute Treatment (ICBAT)	Treatment provided to youth with serious behavioral health disorders who require a higher level of service than those in CBAT programs, including daily psychiatry and increased milieu support.	MassHealth and various private health insurance providers	Must be screened through MCI
Acute Inpatient Treatment	Intensive psychiatric stabilization in a secure 24-hour facility.	MassHealth and various private health insurance providers	Must be screened through MCI or private insurance screening process
Continuing Care	Secure treatment for youth who are considered to be a danger to self or others due to mental illness.	DMH	Acute inpatient referral only
