

OUR HOLLAND & BELGIUM TOUR ITINERARY:

DAY 1 – BOSTON~AMSTERDAM: Depart Boston's Logan International Airport aboard our transatlantic flight to Amsterdam with meal and beverage service, as well as stereo headsets, available while in flight.

DAY 2 – AMSTERDAM~THE HAGUE: Upon arrival at the airport in Amsterdam, we will meet our Tour Escort, who will take us on a panoramic tour of this truly unique canal-lined Dutch city. Later, we'll transfer to our hotel in The Hague, the Ibis Den Haag City Centre (or similar). Our welcome dinner will be at a local restaurant this evening. Overnight at our hotel. DAY 3 – DAY AT LEISURE: After breakfast at our hotel, we are free for the day. Return to our hotel for overnight. (B)

DAY 4 – AALSMEER~MADURODAM~DELFT: After breakfast at our hotel, we are off for a full-day "Grand Holland" tour, visiting the famed Aalsmeer Flower Auction. We will also enjoy a panoramic city tour of Delft, a beautiful city known for its pottery and science, before entering Madurodam, the famed park featuring miniature replicas of Holland. Return to our hotel for overnight. (B)

DAY 5 - DAY AT LEISURE: After breakfast at our hotel, we are free for the day. Return to our hotel for overnight. (B)

DAY 6 – BRUGES~GHENT~BRUSSELS: After breakfast and hotel check-out, we'll enjoy a full-day visit to Bruges and Ghent.
